1.0 Background

Anal skin tags are common and usually harmless growths that hang off the skin around the outside of the anus. They may be mistaken for warts or piles (haemorrhoids). Anal skin tags are not a risk to health and are typically painless or only cause minor symptoms such as itchiness. Anal skin tags can usually be managed conservatively with reassurance and advice regarding anal hygiene. Where patients are experiencing significant symptoms despite conservative management they may require surgical removal. Surgical removal can cause bleeding, pain and infection.

Gloucestershire ICB considers anal skin tags to be symptomatic, and therefore appropriate for assessment and surgical removal in secondary care where they meet at least one of the criteria in this policy. Prior approval must be granted by the ICB prior to referral.

2.0 Policy statement

Policy details

Gloucestershire ICB will only consider funding specialist assessment and treatment of anal skin tags where the patient is for example, suffering from large or multiple anal skin tags that meet at least one of the following criteria. **Prior Approval** must be granted by Gloucestershire ICB prior to referral.

The skin tag is impacting on faecal continence resulting in regular stool seepage.

OR

The skin tag is causing obstruction of an orifice to the extent that function is significantly impaired.

OR

The skin tag is causing continuous pressure symptoms in the course of daily activities such that pain is now restricting normal daily life.

OR

Unavoidable trauma in the course of normal daily activities causes the skin tag to frequently bleed.

OR

There is documented evidence of significant recurrent infection.

3.0 Patients who are not eligible for treatment under this policy

Patients who are not eligible for treatment under this policy may be considered on an individual basis where their GP or consultant believes exceptional circumstances exist that warrant deviation from the rule of this policy.

Individual cases will be reviewed at the ICB's Individual Funding Request Panel upon receipt of a completed application form from the patient's GP, Consultant or Clinician. Applications cannot be considered from patients personally.
